19 This is an action brought by Plaintiff Meadow Vista Protection ("MVP"), a  
20 California non-profit corporation, to enjoin Defendant Chevreux Aggregates, Inc. ("Chevreux")  
21 from mining aggregate and operating an asphalt plant in Meadow Vista. MVP appears to make  
22 three claims of illegal mining. First, it contends that Chevreux's asphalt permit has expired.  
23 Second, MVP claims that Chevreux operates more trucks or truck trips than are permitted by its  
24 various permits and vested rights. Third, MVP claims that Chevreux is mining aggregate outside  
25 the area where it has a permit. Chevreux defends on the grounds that its asphalt permit is in full  
26 force in effect (as determined by Placer County after a public hearing). Chevreux contends that  
27 there are no restrictions in its permit on the number of trucks which can operate from its aggregate


1 site. Finally, Chevreaux claims it has a vested right to mine aggregate in addition to its permit.

2 By order filed August 28, 2007, MVP's then counsel, The Zumbrun Law Firm was  
3 permitted to withdraw and MVP, a corporation, is not presently represented. There is an Order To  
4 Show Cause Re Dismissal set for either October 23, 2007 or October 30, 2007 before  
5 Commissioner Wells. The most recent posting on MVP's website is that it failed to raise the funds  
6 necessary for a retainer for new counsel.

7 It appears to Chevreaux that MVP has abandoned this lawsuit and that it will  
8 dismissed either on October 23 or October 30, 2007.
